We will start receiving \$400.00/month from Edward Jones for ongoing expenses. (Motion by Pattie, Joanne).

Caretaker report:

Billy has been cutting brush. He has noted several areas where dirt has sunk in at new burial sites and asked if the Monument Co is responsible to re-fill these. Beth stated that it is the responsibility of the cemetery to do so. Billy will work on that. He also noticed a burn/char mark on the Pingle gravestone since the Winter burial of Doris Pingle. Beth will call Dave Deering who was the digger for the grave. Billy presented a bid for cemetery mowing at \$200.00 per time and \$10.00/hr for other caretaking duties. Motion made to ok. (Mark, Dixie),

Unfinished business:

1.) Stone maintenance update: We owe Lewiston Monument \$2000.00 for work done last summer on the Swindler and Ritchie stones. We need to find someone to complete the work on other stones. Group suggested we use \$1000.00/yr for stone care. Dixie will contact Lee and Cameron Kennedy who did the work last year and have them sign a contract if interested. Motion was made to set aside \$1000.00/yr, for 5 years for this work. (Mark, Maxine). 2.) New Burials-fees and information packets.

Pattie has put together a booklet of cemetery info to give to new lot purchasers. Group reviewed and will send ideas and changes needed to Beth.

3.) Death Certificates: Beth and Dixie are trying to get one for everyone buried in the cemetery. Cost for MN certificates is \$9.00 each, need 27, for a total of \$243.00. (Motion passed Oct.'14).

Out of state certificates are \$20.00, the total cost would be \$687.00. (Motion to ok, Mark, Billy).

4.) Information sign/Message Center. Group decided on a top hinged door, 52x40 inches, cost with shipping: \$1,092.63. (Motion by Dixie, Beth).

New Business:

- 1.) Cemetery clean up day: Billy and family have been picking up items. We will go after Billy mows the last time prior to Memorial Day to sweep stones, etc.
- 2.) New burials: Doris Pingel Stark, Earl Fakler, Duke Merchlewitz, Jim Storlie.
- 2.) Memorial Day Service will be May 25th at 9:30 AM.
