They discussed the best location for a Columbarium, the size, color choices and cost.

Members then met at the Community Center to discuss options and differences between quotes from Sunburst Memorials and La Crosse Memorials.

The total cost from La Crosse would be \$13,052.00 which includes the pillars and concrete slab.

The total cost presented from Sunburst would be \$10,950.00, for a pre-made columbarium, which is in stock and ready for delivery. The color is China Grey with black doors. Size is a 24 inch niche size, with 12 on each side.
