Lisa Gibbs and Ken Oevering will move the monthly gambling boxes into the back room some time next week and will be paid \$10 per hour.

The 2008 audit recommends an overseer committee to check on the triangle of members, this has been the same recommendation they requested for the last few years. Since our group is small this will always be a problem. Beth Winchester made a motion to accept the audit, with a second from Ken Oevering. Motion passed.

### **Treasurer's Report:**

Cheryl Beeman was not in attendance so Pattie Olsen gave the report, with amount being \$13,752.18. The profit from the teen dance was \$5.75. Dave Johannes would like the cash box and the candy he donated from the ball team back. Paul Moore made a motion to accept the Treasurer's Report with a second from Ken Oevering. Motion passed.

### **Unfinished Business:**

Stockton Community Ball game was held with 10 kids in attendance and 3 fathers playing. We had enough food for 50 people and gave the food for the dance to give out. The dance had about 15 kids, though no teenagers showed.

### New Business:

The playground sign has been broken for a year and a half, Dave Johannes will talk with the company that made our sign for a new frame. Ken Oevering will look at the rules and see if he can build a frame to suit the sign.

Pattie Olsen brought estimates for a new refrigerator. She should bring these estimates to the City Council to be taken out of their funds. She was instructed to get estimates for a new freezer as well. Discussion was held on a dishwasher for the kitchen, this will be researched.
