**Resolution for polling place:** No. 2021-Dec-14 to have 8600 D Street, Stockton Community Center as the polling location for the 2022 elections. Travis McElmury made a motion to accept the resolution, with a second from Lisa Gibbs. Motion passed.

**Resolution for ARPA money:** No. 2021-Dec-14-A to accept \$1,276.93 from the American Rescue Plan act. Money to be used for water or sewer connections, or any sewer, water or street projects and for employee COVID testing or illness. Neil Hjelmeland made a motion to accept the resolution with a second from Lisa Gibbs. Motion passed.

**Dog Park:** Neil Hjelmeland started the discussion to have a dog park in town. It would need fencing and a sign for rules and regulations. Discussion was held on an area to house the park. It could be the 2 lots in Garvin View Estates, any one of the back lots on W. 5<sup>th</sup> Street, next to the Maintenance garage by the creek area or behind the ballfields, or by 8290 W. 6<sup>th</sup> Street lot. **RFP for new Attorney:** Current attorney has retired, and there are 2 in Winona that do Municipal law. A notice for proposal will be sent to them, with a quote date of January 6, 2022 for the Council to look over before the next meeting.

**Beth's vacation:** Clerk Winchester will be on vacation from December 23, 2021 to January 3, 2022. As January 3<sup>rd</sup> will be the employee's holiday of New Year's Day.

## **BUILDING PERMITS**

**New Garage:** Jim Kavaloski at 8950 Old Co. Rd. 23 has the survey finished and a new proposed area for the garage has been drawn. Greg Olson does have the building plans, but no comment has been made. Dave Johannes made a motion to accept the building permit, pending Greg Olson's approval. Motion seconded by Travis McElmury; motion passed.

Money can come from ARPA money. An electrician would need to look at to wire up and see what size generator would be needed.
