The Pledge of Allegiance was said.

Dave Johannes made a motion to accept the agenda, with a second from Neil Hjemeland. Motion passed.

Chad Wangen made a motion to accept the November 27, 2012 minutes, with a second from Neil Hjemeland. Motion passed.

Chad Wangen made a motion to accept the financial report and to pay all bills, motion seconded by Neil Hjemeland. Motion passed.

## **OLD BUSINESS:**

**Non-domestic animals ordinance #7-A:** Chris Parker made a motion to hold a public hearing on January 22, 2013 at 6:45 P.M. to discuss Ordinance #7-A. Motion seconded by Neil Hjemeland. Motion passed.

Dave Johannes repealed his motion for Ordinance #8, since the current ordinance states no chickens allowed. Dave Johannes made the motion to accept Ordinance #8, contingent on accepting Ordinance #7-A in January. Motion seconded by Lisa Gibbs, motion passed unanimously.

**Budget:** No budget changes have been made and no opinions at the Truth in Taxation meeting. Neil Hjemeland made a motion to accept the 2013 budget, with a second from Lisa Gibbs. Motion passed.
