

On Tuesday, February 9, 2021, Mayor Dave Johannes called to order the Stockton City Council meeting at 6:00 PM. Council members in attendance were Lisa Gibbs, Mark Potter, Travis McElmury, and Neil Hjelmeland.

The Pledge of Allegiance was said.

Neil Hjelmeland made a motion to accept the agenda, motion seconded by Travis McElmury. Motion passed.

Mark Potter made a motion to accept the financial reports and to pay all bills. Motion seconded by Lisa Gibbs; motion passed.

Dave Johannes made a motion to accept the January 12, 2021 minutes, with a second by Lisa Gibbs. Motion passed.

### **OLD BUSINESS**

**SAPG Donations:** Pastor Mark Meiers of Grace Lutheran Evangelical Church requested a donation to the Orphan Grain Train. OGT is a non-profit that gives humanitarian aid around the world and USA as well. Shipments of clothing, food, household items and personal hygiene products are shipped by train, semi, or boat. It is 100% volunteer based and 97.2% of dollar amounts do directly to those that need it.

Another project is from Michael Heimermann, he is doing an Eagle Project for a 12-hole disc golf course at Crossing Center in Lewiston. Travis McElmury made a motion to donate \$500 to the Eagle Project and \$250 to the Orphan Grain Train. Motion seconded by Neil Hjelmeland; motion passed.

**Strategic Plan:** Discussion was held on blacktopping City streets and the funding needed. Travis McElmury made a motion to Commit \$200,000 from General Funds to the Blacktop funds. Motion seconded by Mark Potter; motion passed unanimously. Problem areas include E. 8<sup>th</sup> street, E. 9<sup>th</sup> Street from Wacholz Drive to A Street and F Street.

- Add under walking paths, kiosks for a colored walking path plan and look at adult exercise segments.

- Add Splash pad with expense of \$75,000-\$100,000. Also add Pavilion reconstruction.

- Change Community Center to updates and add new lighting.

- Projects to take off the list include Welcome signs, Maintenance garage, Phase III developments, and radium project.
